We agree that we will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain patents for said inventions and for additions and modifications thereto in any and all countries, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.

We hereby authorize and request the Commissioner of Patents to issue said Letters Patent to the Assignee, the assignee of our entire right, title and interest in and to the same, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted as fully and entirely as the same would have been held by ourselves had this assignment and sale not been made.


