**CERTIFICATE OF FOURTH AMENDMENT OF
EIGHTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF COCO COMMUNICATIONS CORP.,
a Delaware corporation**

CoCo Communications Corp., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*Corporation*"), does hereby certify:

ONE: The undersigned is the duly elected and acting President of the Corporation. The original name of the Corporation was CoCo Communications Corp. and the date on which the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware was April 30, 2002.

TWO: That on December 7, 2016, in accordance with the provisions of Sections 141 and 242 of the General Corporation Law of the State of Delaware, resolutions were duly adopted by the Corporation's Board of Directors setting forth, approving and adopting a proposed amendment to the Corporation's Eighth Amended and Restated Certificate of Incorporation (the "*Restated Certificate*") and declaring such amendment to be advisable and recommended for approval by the Corporation's stockholders, and that such resolutions provide that:

Article I of the Restated Certificate is hereby deleted in its entirety and replaced as follows:

"The name of the corporation is Unium Inc. (the "*Corporation*")."

THREE: That on December 8, 2016, the Corporation's stockholders approved such amendment by vote of the requisite outstanding shares in accordance with Section 228 of the General Corporation Law of the State of Delaware.

FOUR: That such amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
