AUTHORIZE AND REQUEST the issuing authority to issue any and all United States and foreign patents granted on such Transferred Rights and improvements to the Assignee;

WARRANT AND COVENANT that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others by the Assignor, and that the full right to convey the same as herein expressed is possessed by the Assignor;

COVENANT, when requested and at the expense of the Assignee, to carry out in good faith the intent and purpose of this assignment, the Assignor will execute all divisional, continuing, substitute, renewal, reissue, and all other patent applications on any and all such Transferred Rights and improvements; execute all rightful oaths, declarations, assignments, powers of attorney and other papers; communicate to the Assignee all facts known to the Assignor relating to such Transferred Rights and improvements and the history thereof; and generally do everything possible which the Assignee shall consider desirable for vesting title to such Transferred Rights and improvements in the Assignee, and for securing, maintaining and enforcing proper patent protection for such Transferred Rights and improvements;

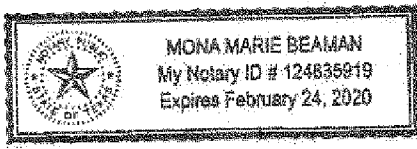
