ASSIGNMENT

or future infringement or any other violation of patent or patent application rights; to have hold for the sole and exclusive use and benefit of the Assignees, its successors and assigns, to the full end of the term or terms for all such patents. The Assignors sell, assign, and transfer the entire right, title and interest to the Assignees as of the day of filing the application identified above.

The Assignors covenant and agree, for both the Assignors and the Assignors' legal representatives, that the Assignors will assist the Assignees in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignees may elect to make covering the invention identified above; in vesting in the Assignees exclusive title in all such other patent applications and patents; and that the Assignors will execute and deliver to the Assignees all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is authorized and requested to issue patents to the Assignees under the terms of this Assignment.
