U.S. PATENT ASSIGNMENT

Whereas, Brian Horowitz (hereinafter "Horowitz"), of Lake Forest, California has invented new and useful improvements (hereinafter referred to as "Inventions"), which have been covered by U.S. patents, the identities of which are listed at Exhibit "A" which is attached hereto and made a part hereof;

Whereas, Stephen Davenport, an individual, (hereinafter referred to as "Davenport") having a mailing address of 3542 Hawkwood Road, Diamond Bar, California 91765 wishes to acquire a 50% (fifty percent) undivided interest in and to the Inventions of Horowitz and in and to the patents therefor as listed in Exhibit A;


Now, therefore, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Horowitz has sold, assigned and transferred and by these presents does sell, assign, and transfer unto Davenport and to his successors, legal representatives and assigns, a 50% (fifty percent) undivided interest in the right, title and interest in Horowitz's Inventions and in Horowitz's patents and any reissues or reexamination thereof, for the territory of the United States of America, said 50% (fifty percent) undivided interest in said Inventions and patents to be held and enjoyed by Davenport for his own use and enjoyment and for the use and enjoyment of his successors, legal representatives and assigns, to the full end of the term for which said U.S. Letters Patents on same has been granted to Horowitz.

Horowitz further grants to Davenport the right to pursue past, present and future infringement and to collect the damages related thereto to be shared with Horowitz pursuant to a separate agreement executed by the parties.

Horowitz hereby covenants that he has the full right to convey the interest herein assigned and that he has not executed and will not execute any agreement in conflict herewith.

Horowitz further covenants and agrees that he will communicate to Davenport and to his successors, legal representatives and assigns, any facts known to him respecting said Inventions and said patents and testify in any legal proceeding, sign all applications, make all rightful oaths, and do everything reasonable to aid Davenport and his successors, legal representatives and assigns to enforce said patents in all jurisdictions.
