## ASSIGNMENT

THIS ASSIGNMENT, by **Sylvester Lee, Isaac Castro, Mauricio Teran, Jamie Hamilton, Carmen Badea, Ravi Patel, and Nathan Brummel** (hereinafter referred to as the Assignors), witnesseth:

WHEREAS, said Assignors have invented certain new and useful improvements, which are described in United States patent application 15/662,159 entitled **MID-AIR ULTRASONIC HAPTIC INTERFACE FOR IMMERSIVE COMPUTING ENVIRONMENTS** and filed July 27, 2017;
