And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **GUANGDONG OPPO MOBILE TELECOMMUNICATIONS CORP., LTD.** as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
