Further, we hereby covenant and agree to and with Yakima Products, Inc., and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.


Further, we agree that we will communicate to Yakima Products, Inc., or its representatives, any facts known to us respecting the invention, and testify in any legal


