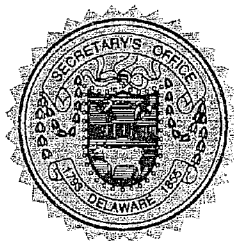

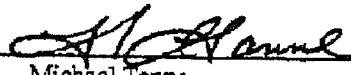
The undersigned, Michael Tanne and David R. Lee, hereby certify that:

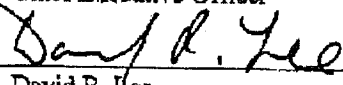
TWO: Article 1 of the Certificate of Incorporation of the Corporation is amended as follows:
