ASSIGNOR further covenants and agrees that it will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known respecting said inventions, applications and registrations, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said inventions, applications and registrations in all countries.
