PATENT RELEASE

THIS PATENT RELEASE is made as of June 21, 2017, by GENERAL ELECTRIC COMPANY, as successor-by-merger to General Electric Capital Corporation, as Collateral Agent ("Secured Party"), in favor of Senoret Chemical Company, a Missouri corporation ("Grantor") for the Lenders and the other Secured Parties. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Grantor and Secured Party were parties to (i) that certain Guaranty and Security Agreement dated as of May 29, 2015 (the "Security Agreement") and (ii) that certain Patent Security Agreement dated as of May 29, 2015 (the "Patent Security Agreement"), pursuant to which Grantor granted a security interest to Secured Party, for the ratable benefit of all of the Secured Parties, in the Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Parties;

WHEREAS, the Patent Security Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on June 9, 2015, at Reel 035859, Frame 0767;

WHEREAS, Grantor has requested that Secured Party execute this Patent Release to evidence the release of its security interest in Patent Collateral and the reassignment of any and all rights Secured Party may have in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party, on behalf of all of the Secured Parties, hereby releases, terminates and discharges its security interest in all of Grantor's right, title and interest in, to and under the following (collectively the "Patents Collateral");

(a) all of its Patents, including, without limitation, those referred to on **Schedule 1** hereto;

(b) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(c) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, violation or other impairment thereof.


