PATENTS AND TECHNOLOGY ASSIGNMENT AND LICENSE AGREEMENT

This PATENTS AND TECHNOLOGY ASSIGNMENT AND LICENSE AGREEMENT ("**Agreement**") dated as of this 25th of April, 2016 ("**Effective Date**"), is between FRESH IDEA GLOBAL LIMITED, a British Virgin Islands company having a place of business at Suite 1208, 12/F, Macau Landmark, 555 Avenida da Amizade, Macau ("**FIGL**"), SOLUTION CHAMPION LIMITED, a British Virgin Islands company having a place of business at Suite 1208, 12/F, Macau Landmark, 555 Avenida da Amizade, Macau ("**SCL**"), and LT GAME LIMITED, a British Virgin Islands company registered in Macau and having a place of business at Suite 1208, 12/F, Macau Landmark, 555 Avenida da Amizade, Macau ("**LT Game**," together with FIGL and SCL, the "**LTG Parties**" or individually, a "**LTG Party**"), on the one hand, and IGT, a Nevada corporation having an address at 6355 S. Buffalo Drive, Las Vegas, Nevada 89113 USA ("**IGT**"), on the other hand. FIGL, SCL, LT Game, and IGT may be referred to hereinafter individually as a "**Party**" and together as the "**Parties**."

1. DEFINITIONS.

Capitalized terms used in this Agreement have the meanings ascribed to them or referenced on Exhibit 1.

2. ASSIGNMENT OF ASSIGNED PATENTS.

- 2.1 **Assignment.** On the terms and subject to the conditions set forth herein, on the Closing Date each of the LT Game Parties hereby conveys, transfers, assigns and delivers to IGT all of the LT Parties' and their Affiliates' respective right, title and interest in and to all of the Assigned Patents listed on **Schedule 1**, for IGT's own use and enjoyment, and for the use and enjoyment of IGT's successors and assigns, as fully and entirely as the same would have been held and enjoyed by the LT Game Parties and their Affiliates if this assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including all claims for damages by reason of past, present or future infringement or other unauthorized use of thereof, with the right to sue for and collect the same for IGT's own use and enjoyment and for the use and enjoyment of its successors or assigns, and any other rights, privileges, claims and causes of action relating or pertaining to such Assigned Patents, free and clear of all claims and liens.
- 2.2 **Further Documentation.** Each LTG Party will sign all documents necessary to further document, record and perfect the assignments contemplated by Section 2.1, which documents will be prepared and, if desired by IGT, recorded by IGT at its expense. Each LTG Party hereby irrevocably designates and appoints IGT as such LTG Party's and its Affiliates' agent and attorney-in-fact to act for and on such LTG Party's and its Affiliates' behalf to execute and file any document and to do all other lawfully permitted acts to further document, record and perfect the assignments contemplated by Section 2.1 with the same legal force and effect as if executed by the LT Game Parties and their Affiliates.

Promptly after LTG Parent has obtained such approval, a LTG Party will notify IGT that such conditions have been satisfied. The date of such notice is the "**Closing Date**". For the avoidance of doubt, anything in this Agreement not specified to become effective as of the Closing Date is effective as of the Effective Date (whether or not it is specified to be effective as of the Effective Date). This Agreement will terminate if the Closing Date does not occur before May 23, 2016 or such other date as may be mutually agreed by all of the Parties.

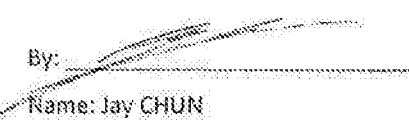

EXHIBIT 1

Definitions

"Affiliate" means, with respect to a first Person, any other Person that directly or indirectly Controls, is Controlled by, or is under common Control with, such first Person.

"HK Listing Rules" means The Rules Governing The Listing of Securities on The Stock Exchange of Hong Kong Limited, which the LTG Parent is subject to.

"IGT" is defined in the preamble to this Agreement.

"*LT Game*" is defined in the preamble to this Agreement.

"LTG Parent" means Paradise Entertainment Limited, the holding company of LTG Parties.

"Party" and *"Parties"* are defined in the preamble to this Agreement.

"Patent" means all classes and types of patents and patent applications (including provisionals, non-provisionals, originals, priority, utility, design, divisionals, continuations, continuations-in-part, extensions, re-examinations, reissues and all other pre-grant and post-grant forms), utility models and applications for utility models, inventor's certificates and applications for inventor's certificates, and other indicia of exclusive rights to an invention or discovery issued by or applied for with any Governmental Authority.
