## ASSIGNMENT

AND I further do acknowledge and agree that I have sold, assigned, conveyed, and transferred, and by these presents do hereby sell, assign, convey, and transfer, unto **ASSIGNEE**, its successors, its legal representatives, and its assigns, all rights of priority under International Conventions, Treaties, or Agreements, and the entire right, title, and interest throughout the world in said **INVENTIONS**, and all patent applications therefor that may have been filed or may be filed hereafter for said **INVENTIONS** in any foreign country, countries, or treaty/union organizations, and all divisional applications, renewal applications, continuation applications, continuation-in-part applications, patent of addition applications, confirmation applications, validation applications, utility model applications, and design applications thereof, and all issued patents which may have granted or may be granted hereafter for said **INVENTIONS** in any country or countries foreign to the United States, and all reissues, renewals, reexaminations, and extensions thereof;



AND I HEREBY covenant and agree that I will communicate promptly to said ASSIGNEE, its successors, its legal representatives, and will cooperate with all reasonable requests from ASSIGNEE, the reasonable costs and time incurred by ASSIGNOR in complying with said communications and requests being borne by the ASSIGNEE, such reasonable requests including testifying in any legal proceeding, signing all lawful papers, executing all applications and certificates, making all rightful declarations and/or oaths, and providing all lawful assistance to said ASSIGNEE, its successors, its legal representatives and its assigns, to obtain and enforce patent protection for said INVENTIONS in all countries;

AND I HEREBY covenant that we will not execute any writing or do any act whatsoever conflicting with these presents
