**CERTIFICATE OF AMENDMENT  
OF  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
FUISZ MEDIA, INC.**

Fuisz Media, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of the State of Delaware (the “**DGCL**”), certifies as follows:

**FIRST:** The name of the corporation is Fuisz Media, Inc. (hereinafter referred to as the “**Corporation**”) and this corporation was originally incorporated pursuant to the DGCL on July 10, 2013.

**SECOND:** Pursuant to Section 242 of the DGCL, this Certificate of Amendment of Amended and Restated Certificate of Incorporation of the Corporation (the “**Certificate of Amendment**”) amends the Amended and Restated Certificate of Incorporation of the Company (the “**Certificate**”) as set forth below.

1. Article First of the Certificate is hereby amended and restated in its entirety to read as follows:

“The name of this corporation is Fuisz Video, Inc. (the “**Corporation**”).”

2. The first sentence of Article Fourth of the Certificate is amended and restated to read in its entirety as follows:

“The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 15,900,000 shares of Common Stock, \$0.0001 par value per share (“**Common Stock**”), and (ii) 7,210,534 shares of Preferred Stock, \$0.0001 par value per share (“**Preferred Stock**”).”

3. The first sentence of Section B of Article Fourth of the Certificate is amended and restated to read in its entirety as follows:

“2,510,534 shares of the authorized and unissued Preferred Stock of the Corporation are hereby designated “**Series Seed Preferred Stock**”, and 4,700,000 shares of the authorized and unissued Preferred Stock of the Corporation are hereby designated “**Series A Preferred Stock**”, each with the rights, preferences, powers, privileges and restrictions, qualifications and limitations as set forth herein. Unless otherwise indicated, references to “sections” or “subsections” in this Part B of this Article Fourth refer to sections and subsections of Part B of this Article Fourth.”


**THIRD:** The foregoing Certificate of Amendment has been duly approved and adopted by the Board of Directors and stockholders of the Company in accordance with Sections 141, 228 and 242 of the DGCL.

**FOURTH:** Other than as set forth in this Certificate of Amendment, the Certificate shall remain in full force and effect, without modification, amendment or change.
