RELEASE OF PATENTS

THIS RELEASE OF PATENTS is dated as of October 2, 2007 by GE CANADA FINANCE HOLDING COMPANY, as Agent ("GE CANADA").

WHEREAS, GE CANADA and Playtex Products, Inc., a Delaware corporation ("Debtor"), entered into that certain Patent Security Agreement, dated as of November 28, 2005, ("Patent Security Agreement");

WHEREAS, the Patent Security Agreement granted GE CANADA a security interest in, among other things, certain Patents and Patent applications ("Patents"), including, without limitation, the Patents listed on Schedule A attached hereto, and in any licenses of patents or patent applications to which Debtor is a party ("Patent Licenses"), as security for certain obligations of Debtor to GE CANADA (the "Obligations");

WHEREAS, GE CANADA recorded the Patent Security Agreement on December 7, 2005 at Reel 016862, Frame 0334 in the United States Patent and Patent Office; and

WHEREAS, Debtor has satisfied all of the Obligations and has requested that GE CANADA release its security interests in the Patents and Patent Licenses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GE CANADA hereby agrees as follows:

GE CANADA hereby fully releases and terminates its security interests in and liens on:


(a) all of Debtor's now existing or hereafter acquired right, title and interest in and to: (i) all Patents which are now filed with the U.S. Patent and Patent Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (A) any reissues, continuations, or extensions thereof, (B) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (C) the right to sue for past, present and future infringements thereof, (D) all documents, packages, prints and labels on which said Patents have appeared and all designs and general intangibles of a like nature, and (E) all rights corresponding thereto throughout the world, and (ii) all Patent Licenses;

(b) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Debtor against third parties for past, present or future infringement of any Patent or of any patent or patent application licensed under any Patent License.

GE CANADA further agrees, at the sole cost and expense of Debtor, to perform all acts reasonably necessary to effect the release and termination of its security interest and including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.

This order is made in connection with the Agreement and Plan of Merger (the "Merger Agreement"), dated July 12, 2007, among Energizer Holdings, Inc. 2. Orders the Trustee to apply such cash to purchase Treasury Bill Series B due February 28, 2008 (CUSIP 912795C90) to be used to pay the redemption price of the Notes, in the amount of 104% of the principal amount to be redeemed, in connection with the redemption referred to below; and
3. Orders the Trustee to give notice, in the form attached hereto as Exhibit A, not later than February 1, 2008, of the redemption of the Remaining Notes, in the name, and at the expense, of the Company in accordance with these written instructions, in order to redeem, in accordance with Section 3.07 of the Indenture, the Remaining Notes on March 1, 2008, and to deliver any funds remaining after such redemption to Energizer Holdings, Inc., attention William C.
