## CONFIRMING ASSIGNMENT

WHEREAS WE, **Philip G. Hill**, of 2037 Allison Road, Vancouver, British Columbia, Canada, V6T 1T2, **Bronson D. Patychuk**, of 580 West 29<sup>th</sup> Avenue, Vancouver, British Columbia, Canada, V5Z 2H7, **Gordon P. McTaggart-Cowan**, of # 503 – 2851 Heather Street, Vancouver, British Columbia, Canada V5Z 0A2 and **Ning Wu**, of # 303 – 2155 West 44<sup>th</sup> Avenue, Vancouver, British Columbia, Canada V6M 2G4, (hereinafter collectively called the “Assignors”), have invented certain new and useful improvements described and claimed in an application for Canadian Letters Patent (the “Canadian Patent Application”), filed on February 10, 2015 with the Canadian Commissioner of Patents in the Canadian Intellectual Property Office. The Canadian Patent Application being entitled:

### **REDUCING UNBURNED HYDROCARBON EMISSIONS IN GASEOUS FUELLED LEAN-BURN ENGINES**

In consideration of the sum of ONE HUNDRED CANADIAN DOLLARS (\$100.00) and for other good and valuable consideration, the receipt and sufficiency of which the Assignors and the Assignee accept and acknowledge, we the Assignors do hereby, both jointly and severally, confirm having sold, assigned, transferred and set over, as of the date of Making the Invention, and by way of further assurance do hereby sell, assign, transfer, and set over, to the Assignee the entire right, title and interest in and to the Patent Rights. This assignment includes without limitation the authorization of the Assignee to file in our names applications for Letters Patents for the Patent Rights, the same to be held and enjoyed by the Assignee, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which the Letters Patent

respectively may be granted, re-issued or extended as fully and entirely as the same would have been held and enjoyed by us, had this assignment, sale and transfer not been made, including the right to bring or participate in any proceedings and the right to full remedies including the right to recover for past, present and future infringement of the Patent Rights.

We the Assignors hereby covenant that we have not executed and will not execute any agreement or assignment in conflict herewith, and we further covenant and agree, each time a request is made, and without delay or further consideration, to do such acts, and execute such further documents, agreements and assurances, at Assignee's expense, that Assignee, its successors, assigns, nominees and legal representatives may, in their absolute discretion, request, in order to protect, perfect, maintain and enforce the Patent Rights herein.

## **II. ACCEPTANCE**

Assignee hereby declares having accepted the Assignor's entire interest in the Patent Rights with all the rights and obligations deriving therefrom.

## **III. ISSUANCE OF FUTURE PATENTS IN THE NAME OF WESTPORT POWER INC.**

We the Assignors hereby authorize and request the Canadian Commissioner of Patents and any official of any country or countries foreign to Canada whose duty it is to issue patents on applications as aforesaid, to issue to the Assignee, as assignee of the entire right, title and interest, any and all Letters Patent for said inventions or improvements, which may be issued and granted on or as a result of the application aforesaid, in accordance with the terms of this Assignment.




