TERMINATION AND RELEASE OF THE GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS AND PATENTS

This TERMINATION AND RELEASE OF THE GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS AND PATENTS (this “Termination and Release”) dated as of August 8, 2017, by JPMORGAN CHASE BANK N.A., as Collateral Agent (the “Agent”) in favor of HUNTSMAN P&A AMERICAS LLC (f/k/a ROCKWOOD PIGMENTS NA, INC.), a Delaware corporation, (the “Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Collateral Security Agreement or the IP Security Interest (as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Collateral Security Agreement (the “Collateral Security Agreement”), dated as of August 16, 2005, the Grantor executed a Grant of Security Interest in United States Trademarks and Patents (the “IP Security Interest”), dated as of October 1, 2014, which was recorded in the United States Patent and Trademark Office at Patent Reel 033871 Frame 0804 and Trademark Reel 5373 Frame 0331, pursuant to which the Grantor granted a security interest to the Agent in the Patents, including certain patents and/or patent applications listed on Schedule A hereto and made a part hereof, and in the Marks, including certain trademarks and/or trademark applications listed on Schedule B hereto and made a part hereof; and

WHEREAS, the Agent now desires to terminate and release its security interest in the Patents and Marks and reassign any and all rights, title, and interest in the same to the Grantor.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Agent hereby releases its security interest in all of the Grantor’s right, title and interest in and to the Patents, including those patents and patent applications set forth on Schedule A.

2. The Agent hereby assigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of the Agent’s right, title, and interest in and to the Patents.

3. The Agent hereby releases its security interest in all of the Grantor’s right, title and interest in and to the Marks, including those trademarks and trademark applications set forth on Schedule B.


