ASSIGNMENT

WHEREAS I, **Masashi IKEDA** of c/o Konica Minolta, Inc., 2-7-2, Marunouchi, Chiyoda-ku, Tokyo 100-7015 Japan (hereinafter referred to as "ASSIGNOR") have invented certain new and useful improvements in:

INKJET INK AND IMAGE-FORMING METHOD
