DEED OF TRANSFER

The undersigned:

1. SkyGate B.V., a private limited liability company, existing and incorporated under the laws of The Netherlands, having its registered office in Amsterdam hereinafter referred to as "the Assignor";

and

2. SkyTech B.V., a limited liability company, existing and incorporated under the laws of The Netherlands, having its registered office in Amsterdam hereinafter referred to as "the Assignee";

hereinafter jointly referred to as "the Parties";

WHEREAS

- The Assignor is the registered owner of the patents, applications of patents and the inventions therein described and claimed (hereinafter referred to as "the Patents" and/ or "a Patent") as set out in Schedule 1 to this Deed (hereinafter referred to as "Schedule 1");
- The Assignee is for good and sufficient consideration under the Asset Purchase Agreement between the Assignor and the Assignee, dated as of March 25, 2004, willing to acquire from the Assignor the entire right, title and interest in and to the Patents;
- The Assignor wishes to assign the entire right, title and interest in and to the Patents to the Assignee on the terms and conditions as set out hereinafter.

THE ASSIGNOR AND THE ASSIGNEE HAVE AGREED AS FOLLOWS:

Article 1 – Preamble

This preamble is deemed to be embodied in this Deed.

Article 2 – Assignment

2.1 The Assignor hereby assigns all its rights, title and interest in and to the Patents as specified in Schedule 1, until the end of the term for which the Patents are granted or reissued as fully and entirely as the same would have been held and enjoyed by the Assignor, if this assignment had not been made (hereinafter referred to as "the Assignment");

2.2 The Assignee hereby accepts the Assignment from the Assignor;

2.3 Parties agree that the Assignee has the right to assign or transfer its rights and obligations under this Deed in whole or in part to an affiliated group company. All expenses incurred in connection with such assignment or transfer shall be for the account of the new assignee/ transferee. No consent of the Assignor shall be required in respect of any such assignment or transfer. Upon such assignment or transfer, the Assignee shall be totally and definitively discharged of all its obligations under this Deed.

Article 3 – Legal Effectiveness

3.1 The Assignment shall take place by this Deed and by legal transfer and set over of the Patents from the Assignor to the Assignee;

3.2 The legal transfer and set over (hereinafter referred to as "the formal substitution of ownership") of the Patents will be effectuated and executed in accordance with the law of the jurisdiction applicable to the relevant Patent on a date to be determined by the Assignor and the Assignee in joint consultation;


3.3 The Assignor and the Assignee have agreed that the Assignor will ensure that the formal substitution of ownership of the Patents is properly accomplished and reflected with the relevant patent registration authorities;

3.4 The Assignor and the Assignee have agreed that the Assignee will take for its account all costs relating to the formal substitution of ownership of the Patents.

6.2 Jurisdiction: Any dispute concerning the validity, interpretation or performance of this Agreement shall be finally settled under the rules of conciliation and arbitration of the International Chamber of Commerce, Paris by three arbitrators appointed in accordance with said rules. The place of Arbitration is Geneva. The proceedings shall be conducted in English. All and any award of the arbitration panel shall be final and binding for the parties.

Clause headings in this Deed are for ease of reference only and in no way affect the contents and the construction thereof.

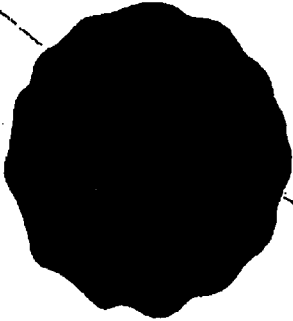
