ASSIGNMENT

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

ASSIGNOR further covenants that ASSIGNEE will, upon his request, be provided promptly with all pertinent facts and documents relating to said invention, said application, and said Letters Patent as may be known and accessible to ASSIGNOR, and will testify as to the same in any litigation before a court of law or an administrative agency or any proceeding before the U.S. Patent Trial and Appeal Board related thereto, and will promptly execute and deliver to ASSIGNEE or his legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce said invention, said applications, and said Letters Patent which may be necessary or desirable to carry out the purposes hereof.

ASSIGNOR requests the Commissioner for Patents to issue any Letters Patent of the United States which may be issued for said invention to ASSIGNEE, his legal representatives, successors, and assigns, as the sole owner of the entire right, title, and interest in and to said patent and the invention covered thereby.
