ASSIGNMENT OF INVENTION

WHEREAS, I, **Raul LAZARO FLORENSA**, Pol.Ind.Can Roses, Avda. Olimpiades, s/n., 08191 RUBI (Barcelona), Spain, have invented certain new and useful improvements in an **IMPROVEMENTS IN DEVICES FOR LEVELLING COVERING PARTS**, for which a national phase application for Letters Patent in the United States is being filed, based upon International Application No. PCT/ES2015/070903, filed on December 15, 2015, claiming priority to Spanish Patent Application No. 201530251, filed on February 26, 2015;

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to me in hand paid, the receipt of which is hereby acknowledged, I hereby assign, sell, and transfer unto said **GERMANS BOADA, S.A.** my entire right, title, and interest in said invention, said application, and in and to any and all Letters Patent of the United States, and countries foreign thereto, which may be granted for said invention, and in and to any and all priority rights, rights under the International Convention For The Protection Of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **GERMANS BOADA, S.A.** as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
