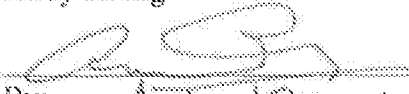
- The Inventions and all rights in any country in the world with respect to the Inventions;

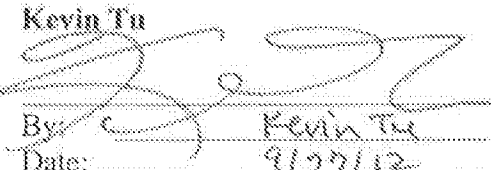

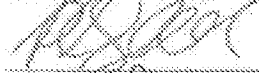
