DEED OF PATENT ASSIGNMENT AGREEMENT

THIS AGREEMENT is m	nade this 3rd	day of	August	, 2017, b	y and between

(1) Mr. Stanley Chung, an individual holding the passport of Republic of Taiwan numbered 301478085, with his address for notice at No. 2 Huaihai Middle Road, Lane 1768, Shanghai 200031 ("Assignor")

and

(2) Roto Frank Asia-Pacific Pte. Ltd. Singapore, a limited liability company duly incorporated and existing under Singapore Law and with its legal address at 24 Raffles Place # 19-05, Clifford Centre, Singapore 048621 (change in progress to 19 Joo Koon Road, Singapore 628978) ("Assignee").

Assignor and Assignee are each individually referred to as a "Party" and collectively as the "Parties".

WHEREAS, Assignor owns the entire right, title, and interest in the patents and patent applications listed in Schedule 1 of this Assignment (collectively referred to as the "Patents"). Assignee wishes to acquire the Patents and all rights in them.

NOW THEREFORE, for and in consideration of the payment of the purchase price for the Patents as stipulated in and in accordance with certain Master Sales and Purchase Agreement by and among the Assignor, the Assignee and other parties listed thereto (the "SPA"), the Parties agree as follows:

1. Assignment. Assignor hereby assigns to Assignee, all right, title and interest in the Patents of every country for the Patents, including divisions, reissues, continuations, renewals, extensions thereof, all rights of priority resulting from the filing of the Patents, the right to apply for patent of the same invention or creation covered by the Patents in any and all jurisdictions, the right to claim all rights of priority of the Patents, and the rights to enforce or exploit any of the Patents. Assignor agrees to execute all documentation and take all actions as reasonably requested by Assignee to effect the assignment of the Patents under this Agreement, and generally to do everything possible to aid the Assignee, at Assignee's request and expense, in obtaining, enforcing and exploiting any and all rights of the Patents in all jurisdictions, and Assignor shall take all actions and make requests to any and all of the competent Patent and Trademark Offices in any related jurisdiction that all the Patents shall be granted to or registered in the name of the Assignee. Assignor shall execute all documentation and take all actions to procure that the competent Patent and Trademark Offices in the relevant jurisdiction, record or register, as the case may be, this assignment of all right, title and interest in the Patents to Assignee.

- 2. Assignor's Representations and Warranties. Assignor hereby represents and warrants that it is the sole owner of the Patents, and owns all the rights, interests, and title in the Patents. Assignor further represents and warrants that it has the legal right and authority to execute this Agreement and to validly assign the entire interest in the Patents to Assignee. Assignor also represents and warrants that it has not executed any other agreement that would conflict with the terms of this Agreement, nor shall they execute any such agreement in the future.
- 3. <u>Further Actions</u>. Assignor hereby agrees to execute any documentation and to take any actions as requested by Assignee in relation to the assignment of any rights of the Patents to any third party as designated by Assignee.
- 4. Governing Law. This Agreement shall be construed in accordance with, and governed in all respects by, the laws of Hong Kong, without regard to conflicts of law principles.
- Dispute Resolution. The provisions of Section 15.2 of the SPA are hereby incorporated by reference and any dispute with respect to this Agreement shall be resolved in accordance with such provisions.
- Counterparts. This Agreement may be executed in several counterparts, each of
 which shall constitute an original and all of which, when taken together, shall
 constitute one agreement.
- 7. Severability. If any part or parts of this Agreement shall be held unenforceable for any reason, the remainder of this Agreement shall continue in full force and effect. If any provision of this Agreement is deemed invalid or unenforceable by any court of competent jurisdiction, and if limiting such provision would make the provision valid, then such provision shall be deemed to be construed as so limited.
- 8. <u>Notice</u>. Any notice required or otherwise given pursuant to this Agreement shall be in writing and mailed certified return receipt requested, postage prepaid, or delivered by overnight delivery service, addressed as follows:
