The Assignor shall without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain the Patents/Applications, and all related applications and patents thereon, in any and all countries, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.

The Assignor authorizes and empowers the Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any of the Patents/Applications and all related applications and patents thereon, filed by the Assignor or the Assignee, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from the Assignor.


