RELEASE OF SECURITY INTEREST IN PATENTS

NOW, THEREFORE, without recourse, representation or warranty and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels and releases its security interest in, and reassigns to the Grantors all right, title and interest in, the Collateral, including the Collateral set forth on Schedule A hereto and (i) all reissues continuations, divisions, continuations-in-part, renewals, improvements or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein, (ii) all renewals and extensions thereof, rights to sue or otherwise recover for infringements or other violations thereof, (iii) all rights corresponding to the foregoing throughout the world, and (iv) all Proceeds, products, accessions, rents and profits of any and all of the foregoing, and any right, title or interest of the Administrative Agent in such Collateral shall hereby cease and become void.

The Administrative Agent shall take all further actions, and provide to Grantor its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor and at Grantor's expense to more fully and effectively effectuate the purposes of this Release. The Administrative Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks of the United States Patent and Trademark Office record this Release.
