ASSIGNMENT

WHEREAS, I, **Kilian Schuster**, a citizen of Switzerland, having a correspondence address of Alpstrasse 23, CH-6020 Emmenbrücke, Switzerland, hereinafter referred to as **ASSIGNOR**, have invented certain new and useful improvements in **ELEVATOR SYSTEM WITH ADAPTIVE DOOR CONTROL**, for which I filed U.S. Patent Application No. 15/552,767 on August 22, 2017, which is a national phase application under 35 U.S.C. § 371 claiming the benefit of priority based on International Patent Application No. PCT/EP2016/053715, filed on February 23, 2016, which claims the benefit of priority based on European Patent Application No. 15156202.2, filed on February 23, 2015.

WHEREAS, **Inventio AG**, a corporation organized under the laws of Switzerland, located at Seestrasse 55, CH-6052 Hergiswil NW, Switzerland, hereinafter referred to as **ASSIGNEE**, is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, I, the **ASSIGNOR**, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the **ASSIGNEE**, its respective successors, legal representatives and assigns, the entire right, title and interest in, to and under the improvements, and the Application and all divisions, renewals, continuations and continuations-in-part thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the improvements to the **ASSIGNEE**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY grant to Pierre R. Yanney, Steven B. Pokotilow, Ian G. DiBernardo, Jeffrey Mann, Kenneth L. Stein, and Jason M. Sobel, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this ASSIGNMENT.

AND I HEREBY further covenant and agree that I will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to me respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.
