In consideration of my employment and/or continued employment by PPG INDUSTRIES, Inc. or its subsidiaries (hereinafter referred as "the Company"), in a capacity in which I may receive or contribute to confidential information concerning the technology and trade secrets on which the Company's business depends, I acknowledge and agree that:

Any inventions, discoveries and suggestions that are related to the business of the Company that are made or conceived by me, either solely or jointly with others, while in the employ of the Company, whether during working hours or not, shall be and remain the sole property of the Company, whether or not patentable; and I will communicate promptly and do hereby assign to the Company all such inventions, discoveries and improvements;

During and after the period of my employment I will execute all documents and will assist the Company in every proper way, without compensation other than my salary, but at the Company's expense, to obtain and enforce patents for such inventions in any and in all countries;

I will not disclose to any person without the Company's written consent, either during or subsequent to my employment, any of the Company's trade secrets or other confidential information;

I will not improperly disclose to the Company, nor induce the Company to use, any trade secrets or other confidential information belonging to others;

Upon cessation of my employment with the Company I will deliver to the Company all records of any nature related to the company business including all copies thereof; and

This agreement shall be binding upon my heirs, legal representatives and assigns.
