## **PATENT RELEASE AND REASSIGNMENT**

THIS PATENT RELEASE AND REASSIGNMENT (this “**Release**”) is made as of June 25, 2014 by MADISON CAPITAL FUNDING LLC, as Agent for the Lenders (“**Agent**”) made in favor of THE RITEDOSE CORPORATION, a South Carolina corporation (“**Grantor**”)

### **W I T N E S S E T H:**

WHEREAS, Grantor entered into that certain Patent Security Agreement, dated as of November 12, 2010 (the “**Agreement**”) in favor of Agent (all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), and pursuant to which Grantor granted a security interest to Agent in the Patent Collateral, including the patents set forth on Schedule 1 hereto;

WHEREAS, the Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on November 12, 2010 at Reel 25358, Frame 0052;

WHEREAS, Agent has agreed to release the entirety of its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Patent Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates the Agreement and releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Patent Collateral, including the following:

(a) Each patent listed on Schedule 1 annexed hereto, together with any renewals, reissues, continuations, continuations-in-part or extensions thereof, all patentable inventions and all inventions and improvements described and claimed thereon; and

(b) All products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.

2. Agent hereby reassigns, transfers, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title


and interest in and to the Patent Collateral and authorizes this Release to be recorded with the United States Patent and Trademark Office.

This Release shall be governed by, as construed and interpreted in accordance with, the laws of the State of Illinois.
