ARISING FROM U.S. PATENT APPLICATION 14/769,046

THIS CONFIRMATORY ASSIGNMENT is made BETWEEN

- 1 Assignor HEREBY CONFIRMS THAT IT HAS ASSIGNED AND TRANSFERRED, and by these presents does assign and transfer, to the Assignee the entire right, title and interest in and to the invention and the Application, and any patents that may issue for said invention in the United States; together with the entire right, title and interest in and to all patent applications (including, but not limited to, divisional applications, continuation applications, continuation-in-part applications) and patents that arise therefrom, including the full right to claim for any such subsequent application all benefits and priority rights under any applicable convention; to have and to hold for sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.
- 2 The Assignee hereby accepts such confirmatory assignment.




