ASSIGNMENT

NOW, THEREFORE, for \$1.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, **RAVINE**, by this instrument does hereby sell, assign, transfer and set over, unto said **New York University**, its successors, legal representatives and assigns, Ravine's entire right, title and interest throughout the world in, to and under the IP Rights including in to under all applications claiming priority to said application, and all divisions, renewals, and continuations of the aforesaid applications and all applications claiming priority to said applications, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and **RAVINE** hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said **New York University**, its successors, legal representatives and assigns,

AND **RAVINE** hereby covenants and agrees that **RAVINE** will communicate to the said **New York University**, its successors, legal representatives, and assigns, any facts known to **RAVINE** respecting IP Rights and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths and generally do everything possible to aid the said **New York University**, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for IP Rights in all countries.


