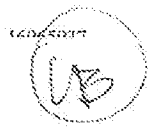

Assignor grants and transfers to Assignee all right, title and interest to sue and recover for any past, present and future infringements of any of the Patents anywhere in the world. Assignor further sells, assigns, and transfers to Assignee the right to pursue and to exclusively own additional intellectual property rights in any product designs or other intellectual property described or disclosed in any Patent, including without limitation any trade dress, copyright or equivalent proprietary right in the United States or abroad.

Assignor hereby authorizes and requests the patent office officials in the United States and in all foreign countries to issue any of the Patents, when granted, to Assignee as the owner of the entire right, title, and interest in and to the same, for the sole use and on behalf of Assignee, its successors and assigns.

Assignor agrees to communicate to Assignee or its representatives any facts known to Assignor with respect to the Patents, and to testify in any legal proceeding, to sign all lawful papers, to execute all divisional, continuation, continuation-in-part, substitution, renewal, reexamination, and reissue applications, to execute all necessary assignment papers to cause all of the Patents to be issued to Assignee, to make all rightful oaths and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper protection for the Patents in the United States and in all foreign countries. Assignor and Assignee further agree that each party shall cooperate and sign additional, separate assignments and other documents as Assignee may desire for recording purposes and to otherwise perfect title in the Patents in the United States and in relevant foreign countries. Assignor hereby irrevocably grants to Assignee a limited power of attorney to sign on behalf of Assignor separate assignments or other documents that Assignee may desire to confirm or affect the transfer of rights set forth in this assignment or to otherwise enjoy the benefits of this assignment, provided that Assignee shall exercise its authority under such power of attorney only if Assignor ceases to exist or Assignee is unable, after exerting good faith efforts, to obtain Assignor's signature on any such document.

Nothing in this assignment, express or implied, is intended or will be construed to confer upon, or give to, any person or entity, other than the parties to this assignment, any rights, remedies,



obligations or liabilities. This assignment will bind and inure to Assignee and Assignor and their respective successors and assigns. This assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same.
