This Assignment is made and entered into by and between **(1) Daniel Kim**, 1 Horizon Road, #1404, Fort Lee, New Jersey 07024, **(2) Nathan Smith**, 1300 La Loma Road, Pasadena, California 91105, **(3) Stephen Blackman**, 2961 Kingston Drive, Buffalo Grove, Illinois 60089, **(4) Sergio Orozco**, 6040 Boulevard East, West New York, New Jersey 07093, **(5) Jinming Pu**, No. 5942 Hu Yi Road, Town of Wai Gang, Jia Ding District, Shanghai, China, and **(6) William Walsh**, 919 Taylor Avenue South, Seattle, Washington 98109 (hereinafter referred to as "INVENTORS"), and **The L.D. Kichler Co.**, an Ohio corporation with its principal place of business at 7711 E. Pleasant Valley Road, Cleveland, Ohio 44131-5552 (hereinafter referred to as "KICHLER").

**Whereas**, INVENTORS have invented certain inventions described in a United States Patent Application titled LIGHTING FIXTURES AND ACCESSORIES, filed on June 2, 2011, and later assigned U.S. Patent Application Serial No. 29/373,878 (the "Patent Application"), which Patent Application INVENTORS have reviewed.

**Now, therefore**, for good and valuable consideration, receipt of which is hereby acknowledged:

1. INVENTORS hereby sell, assign, and transfer to KICHLER, its successors and assigns, the entire right, title and interest, so far as concerns the United States and the Territories and Possessions thereof and all foreign countries, in and to the inventions set forth in the Drawings, the Patent Application, any and all other applications for Letters Patent on said inventions in the United States and in countries foreign to the United States, including all conversion, provisional, non-provisional, divisional, renewal, extension, reexamination, substitute, continuation, continuation-in-part, reissue, and Convention applications based in whole or in part upon said inventions or upon said applications, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications,

and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent.

2. KICHLER is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of KICHLER or otherwise as KICHLER may deem advisable, under the International Convention or otherwise.



6. INVENTORS agree that this Assignment shall be construed in accordance with the laws and courts of Ohio. INVENTORS hereby also agree to submit to the jurisdiction of any Ohio court.


