WHEREAS Assignor is an owner of the letters patent and patent applications listed on Attachment A (collectively, the "Patents"); and


WHEREAS Assignor has agreed with Assignee for the transfer to it all of Assignor's right, title and interest in and to said Patents, and the inventions therein.

AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns that Assignor will, at the cost and expense of the Assignee, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the recordation of this assignment of the Patents to Assignee.

AND Assignor hereby requests the Commissioner of Patents to issue, to Assignee, any and all Letters Patent of the United States arising from such Patents for the use and behalf of the Assignee, its successors, legal representatives, and assigns.

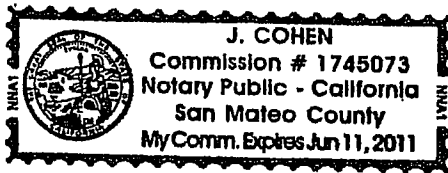
