protection for the Invention and the Application and for vesting title in Assignee to the Invention and all patent applications and patents based on the Invention, but not limited to, the Application;

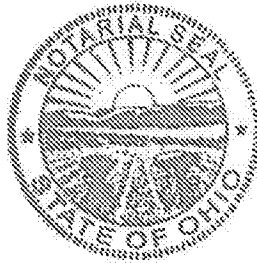

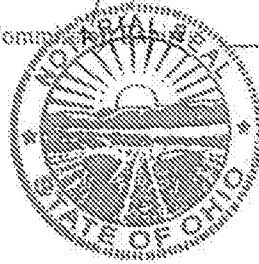
