ASSIGNOR HEREBY further covenants and agrees that, without further consideration, ASSIGNOR will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting said Invention, and will cause to be performed testimony in any legal proceeding, signature of all lawful papers, execution of all divisional, continuing, reissue, reexamination and foreign applications, making of all rightful oaths, and undertaking any other action reasonably requested by ASSIGNEE, its successors, legal representatives and assigns, to effect recordation of this Assignment or to obtain and enforce proper protection for said Invention in all countries.
