PATENT ASSIGNMENT AGREEMENT

THIS PATENT ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of May 22, 2017 by and between Huhtamäki Oyj, organized under the laws of the Country of Finland, having an address at Revontulenkujä 1, 02100 Espoo, Finland ("Assignor") and Huhtamäki, Inc., organized under the laws of the State of Kansas, having an address at 9201 Packaging Drive, De Soto, Kansas 66018, U.S.A. ("Assignee").

WHEREAS, Assignor is the sole owner in full possession of all right, title and interest to the Patent (as defined herein) and desires to convey all right, title and interest in and to the Patent to Assignee; and

WHEREAS, Assignee desires to receive all right, title and interest in and to the Patent.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

ARTICLE 1 DEFINITIONS

For purposes of this Agreement:

"Patent" shall mean U.S. Design Patent Application No. 29/545,060, entitled "INSULATING CUP SLEEVE," filed November 9, 2015, and any and all Letters Patent that may be granted therefor, together with all related continuations, continuations-in-part, divisionals, reissues, revisions, extensions, substitutes, reexaminations, and including all rights to claim priority, and all foreign and domestic counterparts thereof. Notwithstanding the foregoing, for purposes of this Agreement, Patent shall not include any utility patents or utility patent applications, including but not limited to (a) U.S. Patent Application No. 13/130,685, now issued as U.S. Patent No. 9,278,797; (b) U.S. Patent Application No. 15/059,903; (c) PCT Application No. PCT/EP09/65673; (d) German Application No. 10 2009 013 732.7; (e) German Application No. 10 2008 058 797.4; or (f) any other related utility patents or utility patent applications.

ARTICLE 2 ASSIGNMENT

2.1 Assignment. In consideration of the sum of Ten Dollars (\$10.00), Assignor hereby sells, assigns, transfers, conveys and sets over unto Assignee all right, title and interest in and to the Patent within the United States, its territories and possessions, and all foreign countries, along with all causes of action, either in law or in equity, for past, present, or future infringement or misappropriation of the Patent.

2.2 Further Assurances. Assignor further agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title of the Patent rights in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns, such facts relating to the validity and enforceability of the Patent and their rights and the history thereof as may be known to Assignor. Assignor authorizes Assignee to record this Agreement in the United States Patent and Trademark Office and in similar government offices throughout the world.
