
Assignor covenants that he or she has the full right to convey the interests assigned



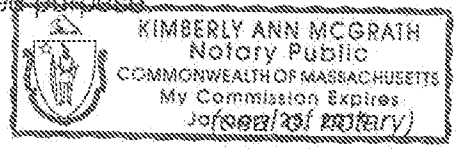
