AND, I hereby authorize and request the Commissioner of Patents of the United States, its territorial possessions, and any and all foreign countries to issue any and all Letters Patent on said invention, or resulting from said application, and from any and all divisions and continuations, extensions, reissues or reexaminations thereof to the said ASSIGNEE, of the entire right, title and interest, and hereby covenant that I have full right to convey the entire interest therein assigned, and that I have not executed and will not execute any agreement in conflict therewith.


