**RELEASE OF SECURITY INTEREST IN IP COLLATERAL**

This RELEASE OF SECURITY INTEREST IN IP COLLATERAL (this “Release”) is made as of August 14, 2017, by Medallion Capital, Inc., a Minnesota corporation and licensee under the Small Business Investment Act of 1958 (the “Secured Party”), in favor of Respiratory Technologies, Inc., a Minnesota corporation (the “Company”). Capitalized terms used and not defined herein have the meanings given such terms in the IP Security Agreement (as defined below).

WHEREAS, the Company is party to that certain Loan Agreement, dated as of April 25, 2012, in favor of the Secured Party (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), pursuant to which the Company executed and delivered that certain Patent and Trademark Security Agreement, dated as of April 25, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”);

WHEREAS, pursuant to the Loan Agreement and the IP Security Agreement, the Company, as collateral security for the payment and performance in full of all the Secured Obligations, pledged and granted to the Secured Party a lien on and security interest in and to all of its right, title and interest in, to and under all of the Patents and Trademarks, including the U.S. patents, trademarks, and applications therefor listed on Schedule 1 attached hereto (collectively, the “IP Collateral”;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on April 30, 2012 at Reel 4767, Frame 0328 with respect to the trademarks and at Reel 028127, Frame 0298 with respect to the patents; and

WHEREAS, the Secured Party has agreed to execute this Release to evidence the release of its security interest in the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

The Secured Party hereby irrevocably terminates, releases and discharges its lien on and security interest in and to the IP Collateral, including, without limitation, the Patents and Trademarks referred to on Schedule I hereto, and re-assigns to the Company any right, title or interest that the Secured Party may have in or to such IP Collateral.

The Secured Party hereby authorizes the Company, or the Company’s authorized representatives, to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Secured Party in the IP Collateral.


The Secured Party shall take all reasonable additional steps requested by the Company as may be necessary to release (or evidence the release of) its security interests in the IP Collateral.

This Release shall be construed, interpreted and the rights of the parties determined in accordance with the laws of the State of New York, without regard to conflicts of law principles or rules that would require the application of the laws of another jurisdiction other than the State of New York.
