NOW, THEREFORE, in consideration of the sum of ten dollars (\$10.00) and other good and valuable consideration by Assignee and/or Consentor to Assignor in hand paid, receipt of all of which is hereby acknowledged, Assignor has agreed to and does hereby sell, assign and transfer unto Assignee, its successors and assigns, all of Assignor's right, title and interest in and throughout the world, in and to said letters patent and patent application and all reissues thereof and re-examination certificates therefore, and the inventions disclosed therein, including Assignor's full right to sue for and recover all damages recoverable from past infringements of said letters patent; including specifically, without limiting the generality of the foregoing, the worldwide letters patent and patent applications listed in Appendix A; and Assignor has further agreed to and does hereby sell, assign and transfer unto Assignee, its successors and assigns, all of Assignor's right, title and interest in and throughout the world in and to said inventions, any other patent applications (including international (PCT), provisional, non-provisional, divisional, continuing, or reissue applications) based in whole or in part on said worldwide letters patent or patent applications or in whole or in part on said inventions, and any and all letters patent (including extensions thereof) of any country which have been or may be granted on any of the aforesaid patent applications or on said inventions or any part thereof; including, specifically, without limiting the generality of the foregoing, the worldwide letters patent and patent applications listed in Appendix A.

4. TO BE HELD AND ENJOYED BY Assignee, its successors and assigns, to the full ends of the respective terms for which said patents have been or may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made.







