I, as ASSIGNOR, hereby authorize ASSIGNEE and its legal representatives to apply for foreign patents on said invention, or based on said application, in ASSIGNEE'S own name or through its successors, assigns, designees, legal representatives, subsidiaries, or related companies, under any International Convention(s) or otherwise, and to enter the filing

date and said USPTO Serial Number of said application for United States Patent in the appropriate spaces above when known.

I, as ASSIGNOR, hereby represent and warrant that I have not granted any rights, titles, or interests inconsistent with the right, title, and interest granted herein.

I, as ASSIGNOR, hereby authorize and request the Commissioner for Patents in the USPTO to issue any of said United States Patents to ASSIGNEE of the entire right, title, and interest in and to any of said United States Patents for the sole use and behoof of ASSIGNEE.

I, as ASSIGNOR, hereby authorize and request the Commissioner for Patents (or the equivalent) in any organizations or countries foreign to the United States to issue any said foreign patent(s) to ASSIGNEE of the entire right, title, and interest in and to any of said foreign patent(s) for the sole use and behoof of ASSIGNEE.

This ASSIGNMENT is governed and is to be construed and enforced in accordance with the laws of the State of Michigan. The invalidity or unenforceability of any provision of this ASSIGNMENT will be construed as if such provision were omitted.
