ASSIGNOR(S) further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said INVENTION, including the patent application listed above, and any Letters Patent and legal equivalents in foreign countries issuing therefrom as may be known and accessible to ASSIGNOR(S), and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said invention and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.

ASSIGNOR(S) and ASSIGNEE each covenant to perform all acts and execute and deliver all documents as may be necessary or appropriate to carry out the intent and purposes of this assignment.

This assignment embodies the entire understanding of ASSIGNOR(S) and ASSIGNEE and supersedes and replaces any and all pre-existing assignments or understandings between ASSIGNOR(S) and ASSIGNEE. No amendment or modification of this assignment shall be valid or binding upon ASSIGNOR(S) or ASSIGNEE unless made in writing and signed on behalf of each of ASSIGNOR(S) and ASSIGNEE by their respective duly authorized representative.
