SHORT FORM PATENT SECURITY AGREEMENT

For good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, **Collateral Opportunities, LLC**, a Delaware limited liability company (the "Grantor") with principal offices at 1500 K Street, N.W., 11th Floor, Washington, D.C. 20005, assigned, granted and mortgaged, by a June 22, 2017 security agreement ("Security Agreement"), to **Cerner Corporation**, with principal offices at 2800 Rockcreek Parkway, Kansas City, MO 64117 (the "Grantee"), a security interest in Collateral, which includes all of the Grantor's right, title and interest in the patents and applications set forth on Exhibit A, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions, priority applications or patents, foreign-equivalents, reexaminations thereof and amendments thereto (the "Patents").

This Short-Form Patent Security Agreement (the "Agreement") is entered into in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

Grantor authorizes the Commissioner for Patents and any other government officials to publicly record and register this Agreement upon request by Grantee.

The effective date of this Agreement is the last date provided below.



