For any patent granted on a patent application assigned herein, we authorize and request that the issuing authority grant and issue such patent to the Assignee.





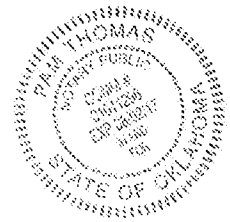
