
representatives to obtain and enforce for its or their own benefit proper patent protection for said invention(s) or improvement(s) in any and all countries.



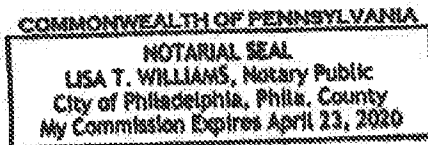

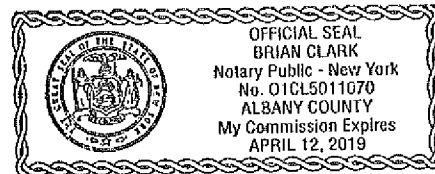
