AND the Assignor hereby sells, assigns and transfers, and does confirm the sale, assignment and transfer, of all of the Assignor rights, titles and interests to the Assignee in all present and future copyright, design right, design registrations or design patents and similar such protection in any work or design relating to the invention in the United States, Canada and in any other country or region throughout the world for the remainder of the term during which the said rights and any renewals or extensions shall subsist, and the Assignor does hereby irrevocably waive their moral rights (including the right to be associated with a work as its author and the right to integrity of a work) and any similar rights or non-assignable rights relating thereto in favour of Assignee and in favour of any third parties as may from time to time be designated by LANCAN SYSTEMS INC.;

AND the Assignor hereby confirms that he is the only inventor of the invention described in the Application;


