Community Design (European), Application No. 003502350, filed on December 6, 2016;


(2) in and to said United States patent application, in and to all other patent applications

invention, and in and to the patent or patents to be granted thereon, including reissues thereof, if any, to the full end of the term or terms for which said patent or patents may be granted; and


