CONFIRMATORY PATENT ASSIGNMENT

This Confirmatory Patent Assignment (the “**Assignment**”) dated effective June 11, 2012, by and between Chen Bardichev, as trustee for Polysack Plastic Industries Ltd. (“**Assignor**”) on one hand, and Polysack Flexible Packaging Ltd. (“**Assignee**”) on the other hand.

WHEREAS, Chen Bardichev was duly appointed as trustee for the liquidation of all the assets of Polysack Industries Ltd. on April 2, 2012, by the Beer Sheva District Court, Southern District of Israel, with full authority to liquidate the assets of Polysack Plastic Industries Ltd.

WHEREAS, Assignor entered into an agreement, for good and valuable consideration, to transfer, sell, and assign all right, title and interest in and to all of the assets of Polysack Plastic Industries Ltd. to Assignee, including but not limited to, all U.S. and foreign patent applications owned by Polysack Plastic Industries Ltd., and specifically the U.S. patent applications listed in Exhibit A (collectively the “**Patent Applications**”).

WHEREAS, the Beer Sheva District Court approved the sale of all the assets of Polysack Plastic Industries Ltd. to Assignee on June 11, 2012, and the sale is now complete.

THEREFORE, for good and valuable consideration paid by Assignee, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR HEREBY confirms having assigned, transferred, and conveyed to Assignee, effective as of the date first referenced to above, all right, title and interest the Patent Applications and all inventions disclosed in those applications, and HEREBY ASSIGNS TO ASSIGNEE:

The entire right, title and interest in the inventions in the Patent Applications and in all divisions, continuations and continuations-in-part of the Patent Applications or reissues or extensions of Letters Patent or Patents granted thereon, and in all corresponding applications which may be filed in countries foreign to the United States, and in all patents issuing thereon in the United States and foreign countries.

The right to file foreign patent applications on said invention in its own name, wherever such right may be legally exercised, including the right to claim the benefits of the International convention for such applications.
