And for the consideration aforesaid, I hereby covenant and agree to and with the Assignee, its successors and assigns, that at the time of the execution and delivery of these presents that I am a lawful owner or joint owner of the entire right, title and interest in and to the invention, the Applications and Letters Patent above-mentioned and that the same are unencumbered, and that I have good right and lawful authority to sell and convey the same in the manner herein set forth;

And for the consideration aforesaid, I hereby covenant and agree to and with the Assignee, its successors and assigns, that I will, whenever its counsel or the counsel of its successors and assigns, learned in the law, shall advise that an amendment, division, continuation, continuation-in-part, or substitution of, or any other proceeding in connection with said application, including interference proceedings, is lawful and desirable, sign all papers and drawings, take all rightful oaths, and do all acts necessary or required to be done for the procurement of valid Letters Patent for said invention, or for the reissue of the same without


