ASSIGNMENT OF PATENT APPLICATION

"MOVING AVERAGE LOW-PASS FILTERING DEVICE AND METHOD"

5) warrant and represent that any assignment, grant, mortgage, license, contract, or other agreements that conflicts with this assignment has not been entered, and will not be entered by the undersigned; and

6) authorize and request my representative, Roger H. Chu, USPTO Reg. # 52745, to insert above the U. S. patent application serial number and the filing date in order to make this assignment suitable for recordation in the United States Patent and Trademark Office.
